
See, I could go on and on. They almost write themselves.

* MORE on RIGS to REEFS From the UC SANTA BARBARA News THE Current

Offshore oil platforms have an immense presence, physically, financially and environmentally. Some 6,000 rigs pump petroleum and natural gas worldwide. But as they extract hydrocarbons from deep beneath the sea, these structures undergo a transformation invisible from above the waves. The ocean claims the platforms' enormous substructures and converts them into vertical reefs, home to millions of individual plants and animals.

While decommissioning a platform is a tall order, a growing number have found new purpose as human-made reefs. Now, researchers at UC Santa Barbara have published a comprehensive study of the history, ecology and pragmatics of rigs-to-reefs efforts in the journal <u>Ocean and Coastal Management</u>.

In addition to assembling information from across a large corpus of work, the scientists hope the study will help inform California residents and policymakers as they decide what to do with platforms slated for retirement off its coast.

- * 4 bunk beds are available for storage or resting.





JULY BEACH DIVE REPORT

Date and Time: July 20th, 2024, 8:00 AM Location: : Deer Creek Beach, Right off of Pacific Coast Highway Weather Conditions: Partly cloudy, 54°F, with a light breeze Water Conditions: Surf: Moderate with 2-3 ft waves. Viz: 2-3 at bottom, Water Temp: 57°F at the at 25 ft.

Marine Life: Saw a large spider crab.

Personal Experience/Recommendation: The visibility was low today, so I recommend bringing a strong dive light. Entry and exit were manageable, but surf was picking up.

Dive Summary: Overall, it was a challenging dive due to low visibility, but it was worthwhile.

Additional Notes: Parking was easy at 8 AM, no restrooms and no state lifeguard. However, we had Sandy, Rob and Carrie overseeing the entry and exit of the divers with O2 on standby.

Personal notes:

Greetings and salutations from Deer Creek! This beach holds a special place in my heart and in my wallet. I remember a time, long ago (though it feels like it was just yesterday), when I was just starting out with my beach diving adventures. On one night dive, the surf decided it liked my brand new atomic mask and one of my jet fins a little too much and claimed them for herself. I never saw them again. Fast forward to this dive, Deer Creek tried to pull the same stunt but not with my gear. This time with someone else's. I will keep the victim's name under wraps, but if it was not for Josh Deer Creek would have scored another trophy.

It was a gloomy morning, and the surf was a little rough. Thank goodness the club has a great support system. Sandy and Rob were supervising the diver's entry and exit, ready to assist if needed with the O2 tanks on standby. Carrie, as always was the angel on the surface, no dive gear, overseeing our safety and ready to help if necessary. On this occasion, one of our new divers struggled to make it through the surf. We have all been there, it is not fun...and Carrie was there to lend a hand helping the diver get back to Rob and Sandy.

I have lost count of the times I have been in a similar situation (but without Carrie, Sandy, or Rob to help me) when the surf just flat out rejected me and forced me to crawl back to shore..often without a fin. It's not fun but over the years I have gotten pretty darn good at it. In fact, ask Mike, Tony, or Wayne—and they can attest that crawling back to shore is like my go-to move... lol





Overall we all had an excellent time. Bilel and I took Ben on his first dive after OW certification, and we had a blast. We dropped in right at the kelp and were meet with 2-ft visibility. Not a big deal since it was not surgy. but we had planned for this. At the bottom, we gave each other the OK and took a heading. We made our way under the kelp patch, which was pitch black, past the reefs, and well beyond in hopes of finding better visibility... but it was not meant to be. On our way back we got separated near kelp and surfaced as planned to find each other. We started talking, and I asked Ben if he saw the spider crab. He replied, "I didn't see anything. The only thing I saw was the light on your tank, and I was just making sure I didn't lose it." We all just had a good laugh... and more importantly he had a good time!!he was a bit bummed out that we did not go back in for a second round but there is always next time... We kicked back to shore and made it through the surf with no issues.

Channel Islands Divers Go Diving for Abalone Conservation Research Report by Rob Johnson


Eric Taylor and I were lucky enough to represent Channel Islands Dive Club on a recent white abalone research dive at Santa Cruz Island.

Professionals from NOAA, California Fish and Wildlife, and the Aquarium of the Pacific were on board to organize volunteers from Southern California to survey two dive sites for all abalone species and possible areas for future repopulation programs.

California Fish and Wildlife divers set out 80 meters of transect line as a reference for us to explore. Eight buddy teams covered 20 meter sections on each side of the baseline. We surveyed our respective areas for abalone, suitable habitat, and adequate food sources. After our dives we reported our findings, which are being compiled for future use.

This is the third year of the study. I would highly recommend that any of our members with advanced open water and above certifications consider volunteering for future studies.

DIVE LOG - JULY 28 SPECTRE TRIP

Location - Backside of Santa Cruz, dive spots Three Sisters and The Drop Off Divers - Sandy, Josh, Tony, Rob, Mark Water temperature - 64/65 degrees Visibility - 30 to 40 feet

As our club librarian Mike F. likes to say, "Best dive ever!" Seriously, these three dives on the backside of Santa Cruz were the best dives at the islands I've experienced in awhile. Our first dive was at Three Sisters where we had plenty of kelp, some surge, many garibaldi and sheephead, and some white abalone and scallops. On our second and third dives at The Drop Off, there was still good kelp, more garibaldi and sheephead, many white abalone and scallops, and a huge sheep crab holding another smaller sheep crab. Mark picked them up! Freaked me out. Once Mark let him go, the large sheep crab quickly moved away, still holding the small crab. On the third dive the surge picked up, and visibility wasn't as good, so we ended our diving for the day, except for Tony. All our dive spots were open to hunting, and Tony made the best of the day by bringing home lots of scallops. On the third dive, he found a nice halibut, which the Spectre crew promptly fileted for him. As Mike says, "Best dive ever!"

IT IS WRITTEN

ARTICLE VII: ELECTION OF BOARD OF DIRECTORS

- a) Nominations for officers shall be accepted at the June, July & August meetings. Announce elections, list board member positions and call for nominations in June, July & August Newsletters.
- b) Nominees for BOD positions shall be active members in good standing and 18 years of age or older. Nominees for president shall be members in good standing for a minimum of 1 year. As defined in Article III section d)
- c) The officers shall be elected at the September meeting for a period of one year.
- d) Newly elected officers shall assume the duties of their respective offices at the October BOD and general meetings.
- e) A majority vote of the members constituting a quorum is required to carry a ballot item.
- f) Officers shall be elected by written ballot.
- g) Ballots shall have a place for write ins.
- h) Ballots will be counted by volunteers appointed at the general meeting.
- i) The election results will be announced at the completion of the counting.
- j) All ballots shall be available for viewing at the BOD meeting following the September general meeting.
- k) If the president does not fulfill her/his term of office, the vice president shall automatically take this office. The new president shall appoint a new vice president and any other vacated positions with the approval of the BOD. All other vacancies shall be filled by presidential appointment.
- I) No board member may hold a specific board position for more than 4 consecutive election years. In the event a term limit is reached and at the time of the election no nominations for that position exist, the existing board member may run for said position for another election year. If no member runs for the position at the September meeting, the BOD may appoint a new member to the position with a majority vote of the BOD.

BOARD MEMBER POSITION

PRESIDENT: Develops agendas and conducts the general and board meetings. Offers assistance to board members unable to fulfill their positions and acts as liaison between the club and its sponsors. Sets up the audio equipment for the general meeting. Writes the monthly "Bottom Times" column for the newsletter and co-signs checks issued by the treasurer. Approximate time it takes to complete duties: 8 - 10 hours per month.

VICE PRESIDENT/SPEAKER SEEKER: Finds speakers for the general meetings. Sets up the video/computer connections as necessary. Introduces the speaker at the meetings and helps the speaker with any set-up. Provides the newsletter editor and web master a bio or other material about the speaker to be put into the newsletter and posted to the website. Conducts general and board meetings when the president is unable to. Approximate time it takes to complete duties: 1 - 3 hours of creative thinking and networking per month.

SECRETARY: Takes minutes of board meetings including any motions passed or proposed. Records the names of guest speakers and any other details of significance at the general meetings and distributes minutes at or before the monthly board meeting. Provides the newsletter editor any major developments from the minutes for the newsletter. Prepares any other club correspondence as necessary. Also, responsible for the storing, inventory, and selling of club tee shirts. Approximate time it takes to complete duties: 3 - 4 hours per month.

TREASURER: Records and tracks all incoming and outgoing monies. Issues checks, after verification of valid receipts, for co-signature by president. Makes bank deposits of all incoming monies, reconciles bank statements, and prepares monthly and year-end financial statements for the board of directors. Sells raffle tickets at monthly general meetings. Provides data for annual tax preparation and filing of tax-exemption paperwork. Approximate time it takes to complete duties: 3 - 4 hours per month.

RAFFLE COORDINATOR: Purchases raffle prizes. Describes raffle prizes, assists treasurer with selling raffle tickets, records prize winners and provides list to newsletter editor for publication. Takes newsletter copies to dive shop sponsors when purchasing prizes. Approximate time it takes to complete duties: 7 - 8 hours per month.

WEB MASTER: Responsible for maintaining the CID website. Provides help and instruction in navigation and use of the website to board and general members. Approximate time it takes to complete duties: 3 - 4 hours per month.

MEMBERSHIP COORDINATOR: Greets and introduces guests, informing them of membership benefits and announces new and renewing members at club general meetings. Maintains current membership list, sends monthly updates to president and web master for email contact lists and club Facebook friends. Sends list of expiring memberships to newsletter editor for publication. Approximate time it takes to complete duties: 8 hours per month.

<u>DIVE COORDINATOR</u>: Plans, with board and general member input, dive charters, trips, and other activities. Makes reservations for and publicizes all activities. Collects fees and liability waivers from participants. Approximate time it takes to complete duties: 4 - 6 hours per month not including organizing a warm water trip or using a dive travel company.

NEWSLETTER EDITOR: Collect, layout, and edits articles from board, general membership, and other sources. At completion, sends newsletter to president for email blast to members, to web master for posting to website, and to raffle coordinator to print and distribute to sponsors when making monthly purchases. Approximate time it takes to complete duties: 10 - 15 hours per month.

<u>CLUB LIBRARIAN</u>: Responsible for maintaining the collection and the organization of library materials so they are available for members use. Handle the checking in and out to the membership. When possible bring collection to meetings. Approximate time it takes to complete duties: 1 - 3 hours per month.

Channel Islands Dive Club Annual Photo Contest 2024 Rules for Entry

For 2024 ONLY. You may submit photos from ALL of 2023 AND 2024 for this year ONLY.

The 2024 Photo and Video Contest is open to all <u>current</u> CID members. Membership must be in good standing at the time you submit your entries and receive a reward. Entries will be evaluated by an independent, non-club member judge appointed by the CID Board. The entries will be anonymous to the judge.

Photos and videos will be evaluated on the following criteria:

THEME - How well the photo/video relates to scuba diving TECHNICAL MERIT - Quality of composition, lighting, contrast, focus, etc. ARTISTIC MERIT - Visual interest, emotional connection, etc.

Prizes for First and Second place will be awarded for each category. Each member may submit only TWO entries per category. However, each member will be limited to one prize per category. In the event the judge selects <u>TWO</u> entries by the same person as the winner for a category, a runner-up will be chosen by the judge for the second place prize.

Contest Categories:

By definition, a CLOSE UP is NOT the same as a MACRO.

Underwater Macro Photo: A true macro shot depends on the level of magnification., essentially it means that you must take pictures where your subject is the same size as your camera sensor or smaller, and it fills the frame. If your camera sensor is one inch wide, you would be photographing something 1 inch or smaller. For this category the macro shot must underwater.

A macro picture not taken underwater can be entered into the topside photo category if it is diving related NOT just beach related.

Topside Photo – can be a wide angle or a MACRO but taken above the water. The subject of the photo must be diving related NOT just beach related.

Underwater Wide Angel Photo: Is anything below the surface but not a MACRO.

Novice: For all non-winners in the past. A NOVICE can submit any, MACRO, WIDE ANGLE or TOPSIDE into the NOVICE category.

Underwater Video: The total length of each submission must not exceed 60 seconds and must be a single, unedited clip. No special effects or titles may be added.

ENTRY FORMAT: Photos in a JPEG Format and Videos in MP4 Format.

DEADLINE: All photo and video entries along with an entry form and release must be submitted to CID's President, Mike Cunningham, by the club's **General Meeting on October 23, 2024**.

You may email to president@channelislandsdivers.org or give to Mike Cunningham on a DVD-Rom or USB Flashdrive. Please make sure your name is clearly printed on the media. Media will be returned to you if you wish at a future club meeting. However, the CID Club cannot be responsible for lost items, so please keep a copy for yourself!
